Dear Father Deeke,

May the Peace of Christ be with you!

As you know, the Diocese is mourning the untimely death of the Reverend Monsignor Kenneth J. Schaefer. This sad event requires me to make pastoral provisions for Our Lady of Mount Carmel Parish in Herrin and Holy Spirit Parish in Carterville. After consultation and prayer, I have decided to appoint The Reverend Mark D. Reyling as Administrator of these two parishes. In a similar manner, after prayer and consultation, I have decided to appoint you to succeed Father Reyling as Administrator of St. Joseph Parish in Freeburg and St. Agatha Parish in New Athens. The effective date of this appointment will be Wednesday, August 19, 2020. (Please review canons 515-544 of The Code of Canon Law). With this letter, I authorize you to act in the name of both parishes in all matters according to Canon 532.

Since you are appointed as Administrator, neither a formal Installation nor the Profession of Faith and Oath of Fidelity are required. However, when you are appointed Pastor, these will be required and the signed documents should be returned to the Bishop's office.

I am deeply grateful to you for your many years of dedicated service at St. Augustine of Canterbury Parish in Hecker, for your unselfish assistance to me at the Bishop's Residence, and for your willingness to take up greater pastoral responsibility with two parishes and a school. I know that the Christian Faithful at St. Joseph and St. Agatha Parishes, knowing the critical situation in the Diocese and realizing it was possible that the Diocese would not have a priest available to serve them if we transferred Father Reyling, will eagerly welcome you and help you to get acquainted with the life of each parish and the local communities. Father Reyling has been a generous and dedicated Pastor, who will be missed by the parishioners. At the same time, I am sure they will want you to serve them in your own way, making good use of your personal talents and gifts. They understand well that no two priests are the same in every respect.

As you assume this new ministry, I urge you to give special attention to St. Joseph Parish School. Be mindful of the sensitive recent difficult decision to close St. Agatha School and that the process of merging that school community with St. Joseph School is underway. Visit the school often, make yourself available to answer the questions that the students and faculty will surely have about the Catholic faith. Be attentive to the Christian formation of young people and the nourishing of vocations to the Priesthood, the Deaconate, and the Religious Life. There is no more urgent need in our Diocese than future priests. Use every opportunity to work and pray for vocations to the Priesthood.

May the Lord who begins this good work in you, dear Father Deeke, bring it to fulfillment. *Oremus pro invicem*.


